- Analysis of website usage so far: limited use of material, traffic peaks coinciding with Webinars → Repeated webinars for effective dissemination of produced material



Cash and WASH webinars


- 3 General TWG webinars in different languages/ time zones in March 2022 with presentation of the roadmap for 2022-2024
 - English/ Arabic / French / Spanish)
 - in total 90 participants
 - 41% had no prior exposure to the TWG
- Technical Webinar focusing on Experience of CVA for WASH in South Asia in November 2022
 - Contributions from Bangladesh & Nepal
 - 40 participants



+C Training IFRC

- In December '22, second facilitation of the RCRCM Market Based Programming for WASH e-Course. It was a mix of eLearning and facilitated sessions.
- The **learning objectives** of this course included a demonstrated technical knowledge on the main modalities to deliver CASH to support WASH outcomes, the key concepts of market assessment and mapping for WASH activities, and the 2021 Global Wash Cluster Market Based Programming in WASH: Technical Guidance for Practitioner.
- 16 participants completed the course and obtained the certificate.
- Due to high demand, replication planned in Q1 2023.
- The course is based on IFRC WASH competency framework level 1 and it introduce the key concepts of CVA and Market Based Programming for WASH outcomes.
- There were 4 scenarios and during the facilitated sessions participants worked in teams to practically applying the concepts learned on CVA and MBP.
