2. CVA technical working group.

After gathering all the interests from the national societies on participation in the main technical areas that we agreed on previously in purpose of extend and exchange the experience together in (CVA with SOP, cash for health, Cash with IM), by the link that was shared previously with COP member, Nagham provide an updates on the members who

- set up the first Draft of the TOR.
- Assign a Working Group Leader

- Agree on final TOR.
- Set the Clear objectives and the results for each member.
- Set a clear Plan of action on strict timeframe for the Working Group
- nominate focal points form relevant technical department to join the Working group.
- Do a baseline for each NSs.

3. Cash and voucher risk register matrix

The presentation was presented by Elias Hazoury who explained the process that the taskforce member went through to design and develop the Risk register from identification the Risks , and elaborate the Roots and impacts for each risk , then analysis the risk severity by understanding the likelihood and impact ,accordingly categorised the risk in different categories , and what is the suitable response strategy , at the end the mitigation measures , then he elaborate the components like (Guideline , risk terminology , Risk categories , and the risk register)¹, in addition to that Nabeh Allaham with mentioning to the methodology of gathering the information to fill the risk register based on (individual discussion between the task force members , internal joint discussion on the participated NSs level , experience and lessons learned of the CVA focal points , and other available practices from the MENA region that reflect the different and complex context .

finished by announcing that the final risk register will be shared on the CASH HUB MEAN page to allow the CVA focal points to reach it out easily and used in designing their CVA projects.

4. Updates from Facilitator Cash regional road map for 2024-2025

Referring to the cash and voucher assistance regional road map importance in leading the MENA region to identify the main interest and priorities for the National societies, the facilitator Nabeh Allaham mentioned to start thinking about developing the new version of
