

Online supported course on CVA and PGI Mainstreaming and Prevention, Mitigation and Response of SGBV in CVA programs



BACKGROUND

In the context of crises, existing inequalities based on gender, age, and individual characteristics can lead to differential impacts. Gender-responsive Cash and Voucher Assistance (CVA) can mitigate these disparities, positively affecting women and girls, enhancing protection, and promoting empowerment. Integrating PGI analysis into disaster management is crucial for strategic project development and execution. While CVA empowers disaster-affected populations, there is a need to address potential risks such as Sexual and Gender-Based Violence (SGBV).

ADDRESSING CAPACITY GAPS

Recognizing ongoing capacity gaps in CVA/PGI and as part of building the capacity of NSs, Finnish Red Cross staff and IFRC staff to implement quality CVA, the IFRC Africa regional PGI Coordinator, IFRC regional CVA team and the Finnish Red Cross PGI Advisor for Africa have identified the need for capacity-building in integrating PGI mainstreamed in all CVA interventions as well as preventing, mitigating, and responding to Sexual and Gender-Based Violence (SGBV) in CVA programming. This collaboration with the Finnish Red Cross will serve as the first cohort and using the materials developed for this training, other cohorts of this training will be conducted.

This will be five-week facilitated online training (3hrs webinar and 1hrs individual exercise every week). The training was customized using the following materials: the IFRC Minimum standards for PGI in emergencies (Cash Section), Gender in Humanitarian Action IASC (Cash-based interventions), Disability Inclusive Cash Assistance, CBM, and CVA and GBV Compendium Training Modules and CARE and the Cash and Voucher Assistance (CVA) and Gender-Based Violence (GBV) online training.

Overall objective

Enhance knowledge in PGI mainstreaming in CVA, particularly in Disability Inclusion, as well as in Prevention, Mitigation and Response of SGBV in CVA programs and equip National Societies Finnish Red Cross and IFRC Operations and Response teams with the necessary tools and skills to effectively integrate it.

Participants

This facilitated online training will be targeting staff of IFRC, NSs and FRC in 12 countries of Africa: Kenya, South Sudan, Somalia, Ethiopia, Burkina, Niger, Sierra Leone, Zimbabwe, Eswatini, Sudan, Burundi, Botswana. The participants targeted in those countries are:

- FRC Country Managers
- FRC CVA Staff
- CVA and/or DM National Society staff.
- PGI NS Focal Points.
- IFRC Ops managers based in Juba, Addis, Niamey, Harare, Pretoria, Khartoum, Freetown, Kinshasa and Nairobi.
- PGI and CVA staff in clusters Africa.
