Meeting minutes:

This COP meeting is considered the eleventh meeting in the series of COP monthly meetings in 2024. It was a good opportunity to cover different points and focus on ongoing activities nationally, regionally, and globally with MENA NSs focal points, and provide an update from the facilitator, in addition to presenting the CVA SOP from Iraqi red crescent.

1. Opening the meeting:

Starting by welcoming the COP members, and explaining the COP agenda points, and mentioning to the main updates on the region level, after long November, with 4 regional and global CVA event:

- Cash community of practice November meeting: with attending 9th NSs ,in addition to CCOE colleagues , for whole day covering the key achievements and challenges of 2024 , in addition to tackle the key recommendation , and priorities for next year .
- Closing CVA mentoring programme: where the updated provided from CCOE side.
- Cash for support services TOT: this training is the first global TOT on the global level, where 21 participants from finance and procurement departments from different 5 regions (AP, America, Africa



, MENA , and Europe) , for 5 days from 17^{th} to 22^{nd} of November , to build the capacity of support services staff in CVA programme , in collaboration between IFRC and NRC .

- **Global PECT training:** the training has taken a place in dubai, in collaboration with NRC, where 24 participants.
- Dignity in action report has been shared on cash hub, with highlighting the key messages on CVA preparedness, building the capacity of NSs , and useful leassons learned on other national societies experiences .

• Training opportunities:

o 2 Online training from CALP side: Core CVA skills for programme staff in january and February , while the links has been shared with .

2. Cash center of excellence CCOE:

a. Closing Cash mentoring programme.

Reem provided more information of the closing of CVA mention programme, where the mentees and mentors meet in person, and present their learning papers, and learning journey,

In addition to that, Reem mention to a research paper that CCOE is working on , the research will focus on the CVA modalities and delivery mechanisms , the survey is ready to be shared with the NSs soon , to provide all relevant information to this topic , to have reach content for this study , Reem present the survey, with navigating quickly through the survey.

b. Translating the dignity of cash to Arabic.

3. Updates from COP members:

• Egyptian red crescent:

Kholod provide the updates on ERC CVA intervention, where ERC manage to start the Cash distribution in late October for Palestinian families to 921 families , and the distribution will continue till the end of December to cover 1500 HH , in collaboration with UNHCR , and ICRC .

ERC conduct a PDM for the families who received cash assistance in the last month and will continue to cover the new received HH.

Norwegian red cross: Michael provide a detailed information on the Global PECT training that has
conducted in NOV, 23 participants have trained from MENA, Europe. Africa, major participants have a
good knowledge of health and operation, for 6 days in dubai from 25th to 30th of November.
